White egrets, tri-colored heron, snowy egrets, roseate spoonbills and even skimmers have taken to the lake.

## **NEW MANAGEMENT COMPANY TO BEGIN APRIL 1, 2020**

Grande Property Services contracted with the three Hammocks' associations boards of directors to manage the affairs of their associations.
