### IMPORTANT!! PLEASE RETURN PROXIES BEFORE THE JAN 26 MEETINGS!

In late December, you will receive *two* packets of information and each packet will include a *proxy* for the two January 26, 2020 Owners' Meetings: one for the Master Association where all owners are members and one for *either* the Preserve Association <u>or</u> Villas Association, depending on where your unit is located. *A quorum is required by state statute for a condominium association to conduct business.* This year, the three associations will meet via Zoom so the proxy <u>must be received prior to the meeting time</u> for you to be counted to make a quorum. You will receive more information about the meetings and how to complete and return the proxies within the next 60 days.

# OWNERS TO VOTE ON AMENDED AND RESTATED MASTER ASSOCIATION DOCUMENTS AT ANNUAL MEETING

The Hammocks Master Association documents were prepared by and for the developer and have been amended on numerous occasions over the last 14 years. The result is a bulky set of governing documents that are difficult to use, outdated in many respects, and inefficient.

As you may remember from our correspondence during the spring, the Board of Directors worked with an attorney to amend the documents for some time. The new documents are meant to eliminate obsolete references to the developer and other non-significant historical information, conform with current provisions of the condominium and corporate statutes and are consistent with current operating procedures.

The first version of the revised documents was mailed to owners for their review last spring. After review of comments and additional discussion among Board and community members, the Board asked the attorney to incorporate recommended changes and additions. A few words about the amendment process may be helpful. **Owners will be asked to vote on each document separately at the January 26, 2021 annual membership meeting.** The necessary vote to approve each document is set forth in beginning paragraphs on the first page of each document.

The Articles of Incorporation and the Bylaws are being replaced in their entirety. These two documents set forth the procedures for the operation of our Association. Many of these procedures are dictated by corporate or condominium statutes, and it is therefore most efficient to adopt new

Articles of Incorporation and Bylaws in conformance with the current statutes rather than spend the extra time to adopt numerous amendments to update our older documents. The operational features unique to our community have been inserted into these documents consistent with our current operations.

It is not possible to replace the Master Declaration with a new Declaration. Our Master Declaration is unique, and we must retain it and work with it. The amendments that have been proposed to the Master Declaration are set forth in the traditional statutory amendment format: new provisions are <u>underlined</u>, and provisions that are been deleted are <u>stricken through</u>. Once adopted, a clean copy of the Master Declaration will be produced without the underlining and strike throughs. The result will be new documents recorded in the public records and filed with the Department of State. More importantly, they will be easier for everyone to read and understand.

# Nature's Corner By Karen Ackinson, Florida Master Naturalist

#### Sandhill Cranes

Among Florida's unique species is the sandhill crane. Standing nearly four feet tall these chortling birds make themselves known to everyone with their deafening calls. The female birds make two calls for every one

of a male. (No jokes here, fellas.) There are actually two types of cranes found in Florida. Non migratory cranes are full time residents of Florida. Their numbers have been estimated at 4,000 to 5,000. They are a protected species and considered threatened. During the winter months it is estimated that 25,000 northern cranes, a different species of sandhill crane make their way here for the warmer climate from the Great Lakes region. These cranes are physically larger than our native cranes.

If you ever witnessed the mating dances of the cranes during the spring it is quite entertaining. The birds make their calls in unison and jump straight up in the air over and over whilst flapping their wings. Their wingspan, by the way can reach up to 7 feet! Sandhill cranes are a monogamous species and typically lay two eggs. These amazing hatchlings walk proudly behind their parents within 24 hours of emerging from their eggs. The birds are omnivorous feeding on

everything from berries and seeds to snakes and lizards. They do not "fish" like herons or egrets.

These beautiful birds can live to 20 years of age, which is longer than most bird species. Threats to the cranes are primarily loss of habitat due to development of grazing land and loss of wetlands.
